Residential outdoor lighting requirements in the State of California have changed. Per the new requirements, timers used to control outdoor lighting must be programmed to OFF during daylight hours and have no more than a 6-hour manual override feature. Finding a timer that meets these new specifications can be challenging. Fortunately, Leviton offers the solution with the VPT24-16Z.

CHALLENGE

Residential new construction in the State of California must meet the 2016 Title 24 energy code requirements for outdoor lighting.

- Outdoor lighting in single-family residential buildings must be controlled by a manual ON and OFF switch that does NOT override to ON and one of the following:
 - Photocontrol and motion sensor
 - Photocontrol and automatic time switch control
 - Astronomical time clock
 - Energy management control system
- Manual override will return to normal operation within 6 hours
- Must be programmed to OFF during daylight hours

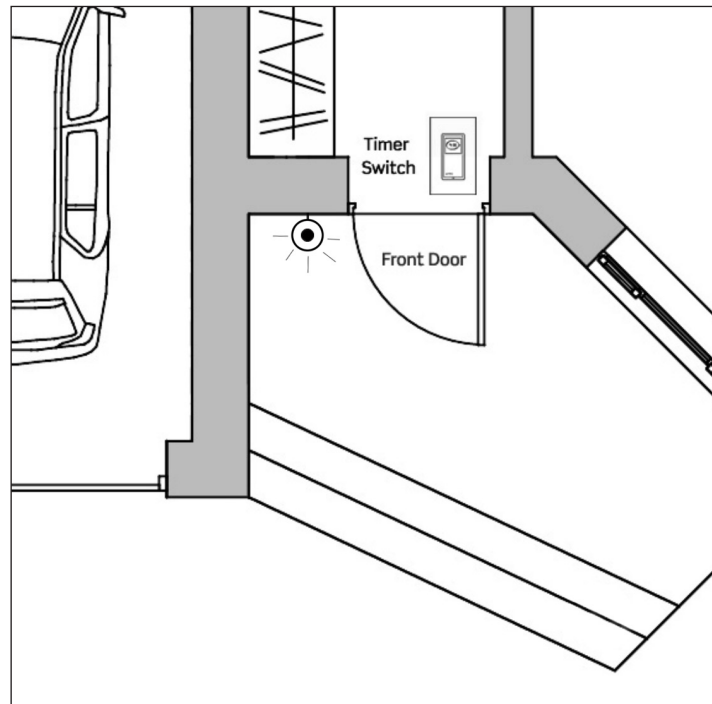
